SSINA RELEASES MARKET DATA FOR JUNE 2010

(Washington, D.C., September 20, 2010) – The Specialty Steel Industry of North America (“SSINA”) has released statistical data on imports, U.S. consumption, and import penetration for June 2010. The data represents U.S. consumption, imports, and import penetration for YTD June 2010 compared to the same 2009 six month period. The following data is presented by specialty steel product line, total stainless steel, and total specialty steel:

- Stainless steel sheet/strip: Imports in YTD June 2010 were 174,740 tons, a 81.7% increase compared to YTD June 2009; U.S. consumption was 631,035 tons, a 53.9% increase; six month import penetration was 27.7%, a 4.2 percentage point increase from 2009.
- Stainless steel plate: Imports in YTD June 2010 were 35,149 tons, a 90.0% increase compared to YTD June 2009; U.S. consumption was 114,021 tons, a 36.4% increase; six month import penetration was 30.8%, a 8.7 percentage point increase from 2009.
- Stainless steel bar: Imports in YTD June 2010 were 48,996 tons, a 20.0% increase compared to YTD June 2009; U.S. consumption was 101,956 tons, a 31.0% increase; six month import penetration was 48.1%, a 4.3 percentage point decrease from 2009.
- Stainless steel rod: Imports in YTD June 2010 were 11,682 tons, a 103.9% increase compared to YTD June 2009; U.S. consumption was 30,489 tons, a 118.7% increase; six month import penetration was 38.3%, a 2.8 percentage point decrease from 2009.
- Stainless steel wire: Imports in YTD June 2010 were 21,275 tons, a 45.9% increase compared to YTD June 2009; U.S. consumption was 26,181 tons, a 24.4 % increase; six month import penetration was 81.3%, a 12.0 percentage point increase from 2009.

Imports of total stainless steel (comprising the foregoing product lines) in YTD June 2010 were **291,841** tons, a 66.0% increase compared to YTD June 2009; U.S. consumption was **903,682** tons, a 49.0% increase; six month import penetration was 32.3%, a 3.3 percentage point increase from 2009.

- Alloy tool steel: Imports in YTD June 2010 were 34,821 tons, a 74.7% increase compared to YTD June 2009; U.S. consumption and import penetration were not calculable.
- Electrical steel: Imports in YTD June 2010 were 45,225 tons, a 6.3% increase compared to YTD June 2009; U.S. consumption was 104,736 tons, a 12.4% decrease from YTD June 2009; six month import penetration was 43.2%, a 7.6 percentage point increase from 2009.

Imports of total specialty steel (comprising stainless steel, alloy tool steel and electrical steel) in YTD June 2010 were **371,887** tons, a 56.1% increase compared to YTD June 2009; U.S. consumption was **1,030,069** tons, a 39.2% increase; six month import penetration was 36.1%, a 3.9 percentage point increase from 2009.
